INDIVIDUAL PERSONAL GUARANTY

1. I expressly waive presentment, demand, protest, notice of protest, dishonor, diligence, notice of default or nonpayment, notice of acceptance of the guaranty, notice of the extending of any guaranteed indebtedness already ore hereafter contracted for by the Purchaser, notice of any modification of renewal of any credit agreement evidencing the indebtedness hereby guaranteed, notice of any renewal or extension of such indebtedness, and I expressly consent to any modification or renewal of any credit agreement evidencing the indebtedness hereby guaranteed and to all renewals or extensions of such indebtedness. I further waive any right to require Seller to proceed against, or make any effort at collection of the guaranteed indebtedness from, the Purchaser or any other party liable for such indebtedness.

3. If the guaranteed indebtedness is not paid by me when due, and this guaranty is placed in the hands of an attorney for collection, or suit is brought hereon, or is enforced through any judicial proceeding whatsoever, I shall pay all reasonable attorneys' fees and court costs incurred by Seller.

4. In the event more than one party executes this guaranty as guarantor, then each guarantor agrees to be jointly and severally liable for the guaranteed indebtedness, and, in all instances herein, the singular shall be construed to include the plural.

AUTHORIZATION & TERMS AGREEMENT

The undersigning and ("Purchaser") agrees that all purchases made by Purchaser from Euclid Fish Company or any of its subsidiaries and affiliated entities ("Seller") are subject to the following terms and conditions:

1. All amounts due seller are payable in accordance with the payment terms granted by Seller's credit department from which the goods and services are delivered. If any amounts due Sellers is not paid in accordance with such payment terms, a delinquency charge shall be added to the sum due, which charge shall equal the amount obtained by multiplying the delinquent balance by the lesser of (a) one and one-half percent (1 ½%) per month or (b) the maximum lawful rate permitted to be charged under the applicable state's law.
2. Purchaser shall pay Seller a service charge in an amount equal to the greater of \$25.00 or 5% of the check balance for all checks returned by Purchaser's bank.
3. In the event the account is turned over to an attorney or other agency for collection, or suit is brought on same, or the same is collected through any judicial proceeding whatsoever, Purchaser shall pay all reasonable attorneys' fees and court costs incurred by Seller.
4. Purchaser shall notify Seller by certified mail of any change of ownership of Purchaser.
